3. **Use on Review** request by Paula Scarborough on the behalf of Joan E. Johnson Estate by Jennifer Lynn Coats for Professional/Medical Offices on a lot shown as Tax Map 065 Parcel 012.00 located off West Madison Avenue zoned R-3 High Density Residential District.

Mr. Casteel said Harlen was there representing the owner. He said he does have an email giving him permission because Paula could not be at the meeting. This is a 12-acre parcel next to Dominion Assisted Living. They want to put a medical professional office there. It is a major arterial, suited for this type of development. He said he did not see any reason why they cannot get a doctor's office on twelve acres. Staff has no problem with this Use in the R-3 District.

Mayor Sherlin asked if this was the property between Dominion and Dennis Street.

Mr. Casteel said it is on the same side as Dominion, the next lot back towards town before the church.

Mr. Proffitt said it has a sewer line running across the middle of the development.

Mr. Casteel said yes, that is something they will have to deal with. He showed the Board where the parcel was located.
